## d. Sponsorships

#### Miscellaneous -

- Uniforms will be ready Friday and will distribute to teams on Sunday. Will arrange to be at the Concessions stands on Sunday to meet coaches. If Board Members have practice Saturday or Sunday, be sure to pick up your uniforms.
- Concessions and Umpire Sign-ups are both live.
- Board member on duty at concession stands needs to pay the umpires each night.
   Each Umpire will have an envelope in the safe with their name on it and payment for each game will be in the envelope. Board member is required to pay them for the game they umpire and have them sign their initials on the envelope next to the appropriate date. Payment for each game is \$60
- Background Checks Russ Clark will have them sent to board members electronically for them to complete, this is for both new and existing board members. County will decide on who will need to have the check performed or not. This applies for umpires, managers and coaches as well.
- Concessions Rob Vos is taking over concessions. There is an opening and closing checklist inside the concession stand but will be sent out to everyone as a reminder. The Board Member who is on duty will be responsible for grilling unless a volunteer has specifically requested to do so.
- Propane Heath will be asked to take over the responsibility of filling up propane tanks when needed.
- Smoking communications have gone out in the past but another one will be sent as a reminder that there is no smoking at CCLL. Consideration needs to be given to replacing existing signage to remind people of the no smoking policy. Parents need to be reminded that when they signed up to play at CCLL, there was a pledge not to use tobacco products at the ball field. Michele will send out another reminder email.
- Safe(s) Elizabeth will purchase a new safe for concessions. Possibly one for the iPad and one for the cash.
- Suggestion to allow a single coach on the field for minors was agreed to by the Board.
